## PortalProdigy EULA

**AGREEMENT.** IMPORTANT --- READ CAREFULLY. THIS IS A CONTRACT. This End User License Agreement (EULA) is a legal agreement between either an individual or a single entity (You) and Portal Prodigy, Inc. (PortalProdigy).

The PortalProdigy software product (SoftwareProduct) includes but is not limited to computer software, computer program code, digital images, graphical interface style, architecture, structure, methods, organization, design, algorithms, templates, data models, data structures, flow charts, logic flow, screen display, method of website administration, documentation, associated media, printed materials, and "online" or electronic documentation and any updates, patches, edits and supplements to the original SoftwareProduct provided to You by PortalProdigy.

By clicking the "I Accept" button on the download page or installation dialog window, or by installing, copying, accessing or otherwise using the SoftwareProduct, You are agreeing to be bound by the terms of this EULA, including the WARRANTY DISCLAIMERS, LIMITATIONS OF LIABILITY, and TERMINATION PROVISIONS. If You do not agree to the terms of this EULA do not press the "I Accept" button and do not install or use the SoftwareProduct.

PortalProdigy is willing to license the SoftwareProduct only upon the condition that You accept ALL of the terms of this EULA. By installing, copying, downloading, accessing or using the SoftwareProduct, You are consenting to be bound by and become party to this EULA. If You do not agree to the terms of this EULA, do not install or use the SoftwareProduct.

**GRANT OF LICENSE.** The SoftwareProduct is licensed, not sold, under the terms of this EULA. PortalProdigy reserves all rights not expressly granted to You. PortalProdigy retains the ownership of the SoftwareProduct.

The SoftwareProduct is licensed to operate on only one hostname or IP address. This EULA grants You the non-exclusive and non-transferable right to use only one licensed copy of the SoftwarProduct for one website on one web-server (License), such License to be identified by a URL specific registration number supplied by PortalProdigy (RegistrationNumber). A separate License must be purchased for each website using the SoftwareProduct installation. The License may not be shared or used concurrently on different computers or servers.

Any Trial Version of the Software Product grants You the right to test the software without a URL specific Registration Number for 90 days free of charge or until You make Your website available to visitors on the Internet, whichever comes first.

**THIRD PARTY WEBSITE DEVELOPMENT.** Website developers may wish to use the SoftwareProduct to build and maintain a website for their client or customer thusly

distributing a customized or altered product. In such cases, the SoftwareProduct may be licensed to such client or customer provided such client or customer accepts this EULA. Third party developers may contact PortalProdigy about distribution of the SoftwareProduct, and if agreeable terms can be determined, the SoftwareProduct may be distributed according to the agreement. The SoftwareProduct may become supported by the party designated in the agreement.

**NO RIGHT TO TRANSFER.** You may not sell, assign, rent, lease, lend, distribute, export, host, act as an intermediary or provider or in any way distribute or transfer any rights in this EULA or the SoftwareProduct to third parties without PortalProdigy's written approval.

**EXPORT RESTRICTIONS.** The SoftwareProduct is subject to U.S. export jurisdiction. You agree to comply with all laws that apply to the SoftwareProduct, including U.S. Export Administration Regulations and any other restrictions issued by U.S. and other governments.

**INTELLECTUAL PROPERTY RIGHTS.** PortalProdigy reserves all intellectual property rights, including copyrights, and trademark rights.

You agree that PortalProdigy is the sole owner of all intellectual property rights related to the SoftwareProduct including but not limited to the computer software, computer program code, digital images, graphical interface style, architecture, structure, methods, organization, design, algorithms, templates, data models, data structures, flow charts, logic flow, screen display, method of website administration, documentation, associated media, printed materials, and "online" or electronic documentation and any updates, patches, edits and supplements to the original SoftwareProduct

The SoftwareProduct is owned by PortalProdigy and is protected by U.S. and international intellectual property and copyright laws and treaties. You agree not to remove or alter any copyright notices in or on the SoftwareProduct. The SoftwareProduct is licensed, not sold. You may not use, copy, or distribute the Software Product, except as granted by this EULA, without written authorization from PortalProdigy. You are not granted any rights in connection with any trademarks or service marks of PortalProdigy and the SoftwareProduct.

You may not reverse engineer, decompile, or disassemble the SoftwareProduct. You have the right to make changes to the HTML code and images of the SoftwareProduct at Your discretion provided SoftwareProduct is used in compliance with this EULA and on condition of copyright reservation. Although rights to modification of the HTML code and images of the SoftwareProduct are granted by this EULA, you may not tamper with, alter, or use the SoftwareProduct in a way that disables, circumvents, or otherwise defeats any built-in licensing verification and enforcement capabilities. Furthermore, any limited right to modify the SoftwareProduct does not include the right to remove or alter any trademark, logo, copyright or other proprietary notice, legend, symbol or label in the SoftwareProduct.

You acknowledge and agree that any and all Intellectual Property Rights to or arising from the the SoftwareProduct are and shall remain the exclusive property of PortlaProdigy. Nothing in this EULA intends to transfer any Intellectual Property Rights to, or to vest any such Intellectual Property Rights in You. You are only entitled to the limited use of the Intellectual Property Rights granted to You in this EULA.

With the exception of PortalProdigy's Intellectual Property Rights, You retain the intellectual property rights You may have in the applications, materials, products or processes You create which utilize the SoftwareProduct. You hereby release and covenant not to hold PortalProdigy, its affiliates, parents, subsidiaries, employees, directors, officers, successors, assigns, distributors and anyone else associated with PortalProdigy liable for any and all damages, liabilities, causes of action, judgments or claims pertaining to any intellectual property You develop that is based on, uses, or relates to the SoftwareProduct or otherwise may arise in connection with Your use of, reliance on, or reference to the SoftwareProduct. Should You decide to communicate to PortalProdigy any information (including, without limitation, ideas, concepts, or techniques for new or improved services and products), whether as information, feedback, data, questions, comments, suggestions, or the like, You agree such submissions are unrestricted and shall be deemed non-confidential and You automatically grant PortalProdigy and a royalty-free, worldwide, perpetual, irrevocable license, with the right to sublicense, to use, copy, transmit, distribute, create derivative works of, display, and perform the same.

**THIRD PARTY RIGHTS.** Any software installed along with the Software Product that is associated with a separate license agreement is licensed to you under the terms of that license agreement. This EULA does not apply to those portions of the SoftwareProduct.

**BACKUP COPY.** You may keep copies of the SoftwareProduct solely for backup or archival purposes. Except as expressly provided in this EULA, you may not otherwise make copies of the SoftwareProduct. Backup and archival copies may not come into active use for any purpose. No other copies may be made.

**SUPPORT:** You agree that PortalProdigy is under no obligation to provide any kind of support whatsoever.

PortalProdigy may, at its sole discretion, provide You with support services related to the SoftwareProduct ("Support Services"). PortalProdigy may, at its sole discretion, make available updates, enhancements, and/or modifications to the SoftwareProduct and may provide such updates to You, but is under no obligation to do so. You agree that PortalProdigy is not required to notify you of or to provide you freely with any upgrades to the Software and You agree that PortalProdigy may, at its sole discretion, provide updates, enhancement, modifications or support on a fee paid basis. Termination of the EULA does not release you from any of your Intellectual Property Rights obligations to PortalProdigy provided for in this EULA.

## UPGRADES, VERSION CHANGES AND FEATURE DEVELOPMEMNT.

PortalProdigy, at its sole discretion, reserves the right to add features or functions, delete features or functions and to provide programming fixes, updates and upgrades, to the SoftwareProduct. You agree that PortalProdigy has no obligation to make subsequent versions available to You.

It is Your obligation to review and test any new upgrade, patch, fix, addition, modification or other change to the SoftwareProduct, in order to verify the continuity of any feature You may have used in an earlier version and plan to continue to use in a newer version. You agree that PortalProdigy has no obligation to continue to provide any feature, component, computer software, computer program code, digital images, graphical interface style, architecture, structure, methods, organization, design, algorithms, templates, data models, data structures, flow charts, logic flow, screen display, method of website administration, documentation, associated media, printed materials, and "online" or electronic documentation in newer versions.

In the event You choose to download, install or use a new version of the SoftwareProduct, You may be required to enter into a renewed version of this EULA, but, in any event, shall still be bound by this EULA.

PortalProdigy disclaims any liability in relation to the direct or indirect damages caused by any release and/or the absence of release of new versions of the SoftwareProduct.

In all cases where You are provided an upgrade, patch, fix, addition, modification or other change to the SoftwareProduct, You agree to accept upgraded product only in accordance with the terms of this EULA unless You are required to enter into a renewed version of this EULA.

If any dispute arises under this EULA, the prevailing party shall be reimbursed by the other party for any and all legal fees and costs associated therewith.

**PARTIAL INVALIDITY.** Should any term or provision hereof be deemed invalid, void or enforceable either in its entirety or in a particular application, the remainder of this Agreement shall nonetheless remain in full force and effect.

**NO WAIVER** No waiver of this EULA, or of any covenant, condition or limitation contained in this EULA, shall be valid unless agreed to in writing by PortalProdigy. No waiver of any right or power hereunder, at one or more times, shall be deemed a waiver or relinquishment of such right or power at any other time or times. A waiver of any breach shall not waive any subsequent breach.

**GOVERNING LAW.** The validity, construction, and performance of this Agreement will be governed by the substantive law of the State of New Jersey in the United States of America. Any dispute arising from this EULA shall be bound to the jurisdiction of the courts in the State of New Jersey in the United States of America.
